Note: The Funeral Rule of the Federal Trade Commission requires any funeral provider that deals directly with the public to offer a general price list for retention by the customer without obligation upon a request made in person. It also requires funeral providers to give price information by phone, and callers are not required to identify themselves. The FTC defines a funeral provider as an entity that (1) offers funeral goods, (2) offers services to care for and prepare bodies for final disposition **and** (3) offers services used to arrange, supervise or conduct a funeral ceremony of final disposition. Nearly all funeral homes and all crematories that serve the public directly meet this definition. Some cemeteries do; others do not.

## Licensed Funeral Transport Providers

Note: Licensed funeral transport providers remove bodies from the place of death and transport bodies to the place of final disposition. A family serving as its own funeral director may transport its own dead in North Carolina. (No burial transit permit is needed unless the death was under the jurisdiction of a medical examiner or the body is to be shipped across state lines.) However, because funeral transport is a licensed occupation, if you pay someone to transport the dead, the person must be licensed as a funeral transport provider. The following is a list of licensed funeral transport providers in the Piedmont Triad. Some will work only for funeral homes, while others will work directly with the family, saving them the basic services fee that a licensed funeral home can charge. You will need to call for yourself to inquire about each provider's availability.

## Backhoe Operators, Gravediggers

Grave digging is not a licensed occupation in North Carolina. If you are using a funeral home, your provider will take care of this task. Families serving as their own funeral directors will find that many cemeteries will supply this service. Otherwise, it is wise to find an individual who has experience in digging graves and a reputation for reliable work in this area. A good source of gravediggers often is the staff of a church that has its own graveyard.

## **Special Services**

In the past decade, the number of options for final disposition has abounded. This is not a comprehensive listing, but a sampling:

### **Natural (or green) cemeteries**

The closest natural cemetery site is Chapel Hill Memorial Gardens. (Actually, it is a traditional cemetery that has set aside one portion to operate as a natural burial ground.) Chapel Hill Memorial Garden in Chapel Hill recently set aside a portion of its cemetery as North Carolina's first "green" burial grounds. Neither embalming nor outer burial containers will be allowed. Caskets must be made of renewable woods, using minimal metalwork and non-toxic glues. Located in a wooded glen, the site plans to prepare graves in a manner that removes the mulch and soil in layers, then replaces them in inverse order, so that the mulch forms a top mound that will gradually settle. Sites will be covered with natural native species. The company that owns the site, Landquest Development, hopes that stones unearthed at the site can be the source of any grave markers used. They also plan to establish a small outdoor pavilion that families can use for simple services or for resting during subsequent visits. Prices had not yet been definitely fixed, but will be more than the memorial garden's traditional plots because they are larger and require more expensive methods and equipment in preparation. The site is located one mile north of Route 40 on the east side of Route 86. Further away, but closer to the hearts of environmentalists because of the example it set for greening America's burial practices is Ramsey Creek Preserve in Westminster, S.C. Memorial Ecosystems Inc. opened Ramsey Creek preserve in 1996, the first "green cemetery" in the United States. The preserve was formed to harness the funeral industry for land protection and restoration, to fund non-profits, education, the arts and scientific research, and to provide a less expensive and more meaningful burial option. This cemetery aspires to protect, restore and permanently endow one million acres of wild-lands over the coming decades. More than merely financing protection, the inherently spiritual nature of our

endeavor means that we can foster closer ties between human communities and the natural communities that they depend on. According to its website, “Our main focus is to develop multi-functional memorial nature preserves that we create with the cooperation and assistance of non-profit organizations. Through becoming members of the preserve during life, and choosing burial in the preserve after, our clients leave a permanent legacy for their families, their communities and the natural world. ## Anatomical Donations

The closest anatomical bequeathal program is at the Department of Neurobiology and Anatomy of Wake Forest University School of Medicine, Medical Center Blvd., Winston-Salem NC 27157-1010; (336) 716-7369. Bodies that are obese, extremely emaciated, mutilated, deteriorated, or where death is attributable to a highly communicable disease, are unacceptable, as are bodies which have been autopsied or from which organs have been removed. You may bequeath your body to the program by completing two copies of its bequeathal form, which FCA of the Piedmont members receive in their resource binders. Bequeathals

are subject to the approval of the next of kin, who must sign a release of the body to the school. A local undertaker or funeral transport service should be contacted at the time of death and requested to call the office to arrange for delivery of the body. The family or estate is responsible for paying the cost of this transportation. At the conclusion of the study, the remains are cremated and, upon request, returned to the family or a funeral home.
